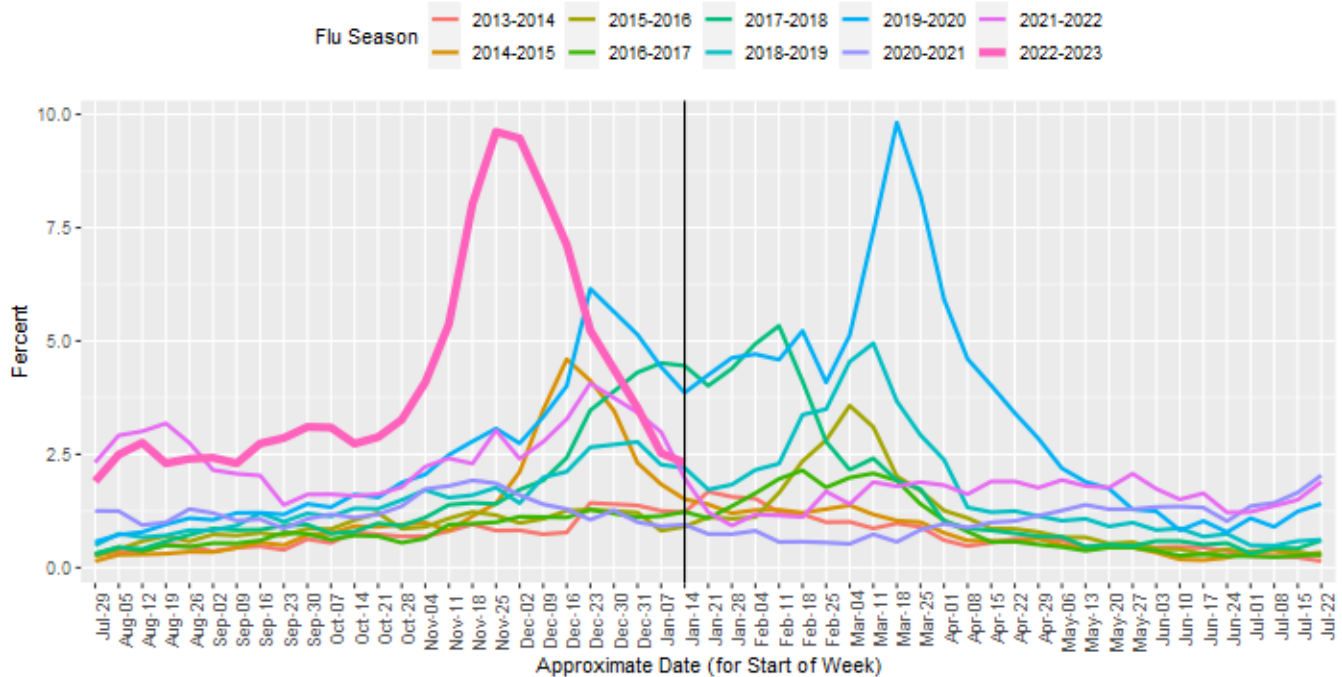

Influenza-like Illness ED visits in Marion County continued to decrease during the last week.

- During week 03 (January 15 to January 21), **2.31% of Marion County ED visits had ILI symptoms**. This rate was lower than last week (2.54%). The median percent of ILI-related ED visits for week 03 in the last five years (2019-2023) was 2.23%.
- In Marion County hospitals, 0-4 years old and 5-17 years old had the highest rate (5.21%) of ILI related ED Visits. The median percent of 0-4 years old ILI-related ED visits for week 03 over the last five years was 6.94%. The median percent of 5-17 years old ILI-related ED visits for week 03 over the last five years was 5.62%.
- **ED visits for Respiratory Syncytial Virus (RSV) and other respiratory illnesses for 0-4 years old continued to decrease** during the last week.
 - RSV is a common respiratory virus that is the most common cause of bronchiolitis and pneumonia for children under 1 year of age in the U.S

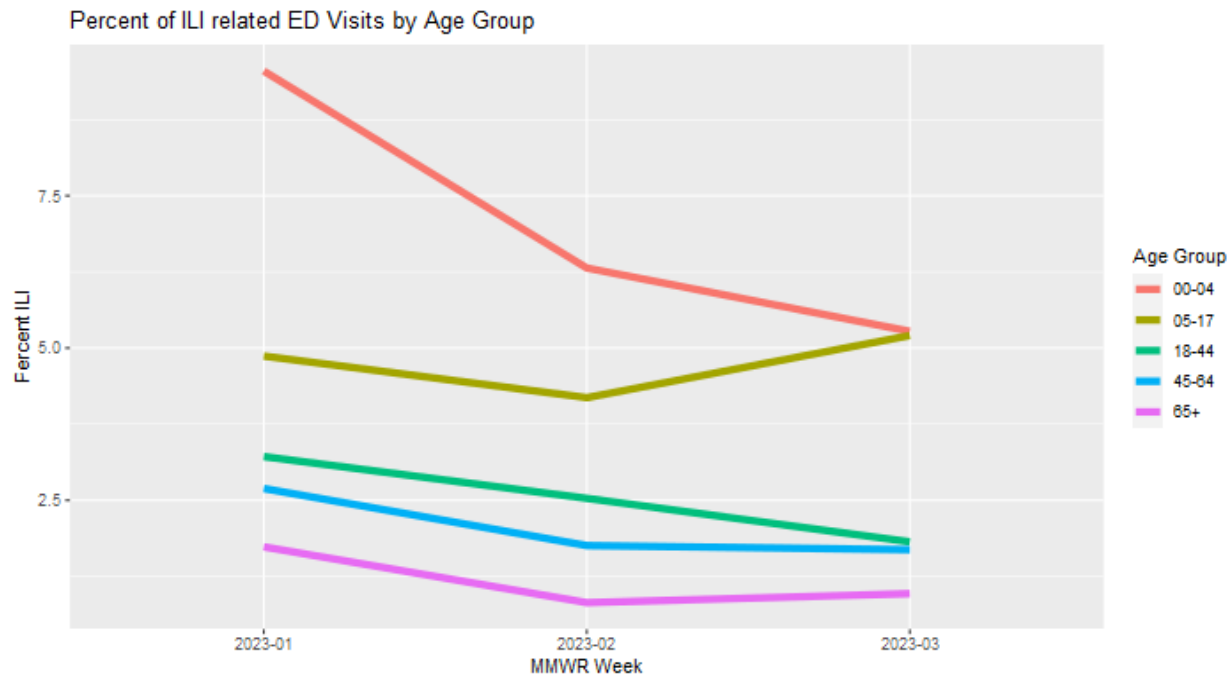

Marion County (Week 02, January 01, 2023- January 07, 2023)

- The percentage of ILI-related ED visits was 2.54% out of all ED visits.
- In Marion County hospitals, 0-4 years old had the highest rate (6.32%) of ILI related ED Visits.

Indiana (Week 02, January 08, 2023- January 14, 2023)

- Indiana is experiencing **Low** ILI activity. For week 02, IDOH reported 2.12% ILI at sentinel provider sites and 2.03% ILI at ED and urgent care visits. Both rates decreased during the last week.
- There have been **one hundred fifty-six influenza-associated deaths** this season, **ten** of those Influenza-associated deaths were detected for the week 02.
- Three specimens were tested at the IDOH Laboratory during Week 02. One was detected as Influenza A/ H1N1 and two were detected as Influenza negative.

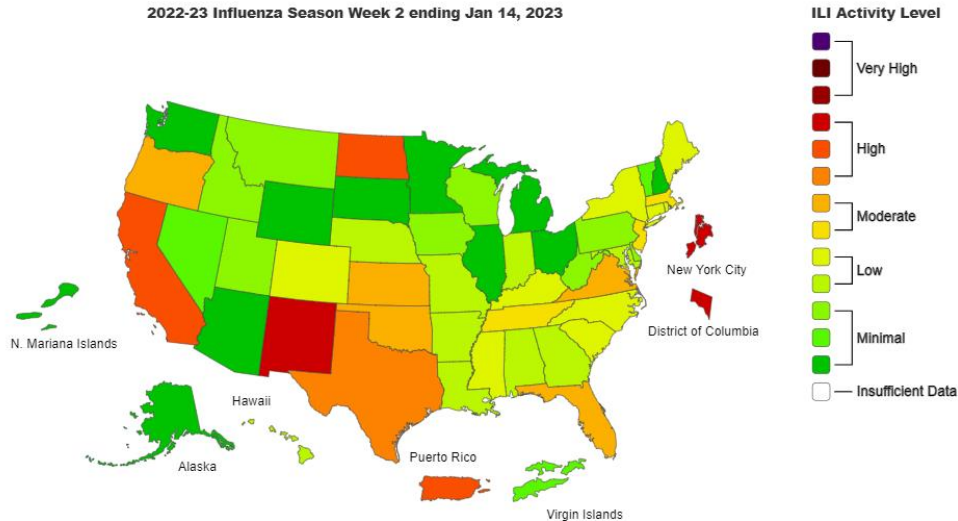

- Seasonal Influenza activity continues to decrease across the US.
- Of outpatient visits to a healthcare provider, **3% were ILI-related**, as reported through the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet). This rate is lower than the last week (4%) but higher than the national baseline of 2.5%.
- **Six influenza-associated pediatric deaths were reported to CDC** during the week 02. All six deaths were associated with influenza A viruses. Eighty-five influenza-associated pediatric deaths occurring during the 2022-2023 season have been reported to CDC.
- During Week 02, **4.6% of clinical laboratory specimens** were **positive for influenza**. This rate is lower than last week (8.6%).
- During Week 02, **453 (7%) specimens** were **positive at public health laboratories**. This rate is lower than last week (11%).
