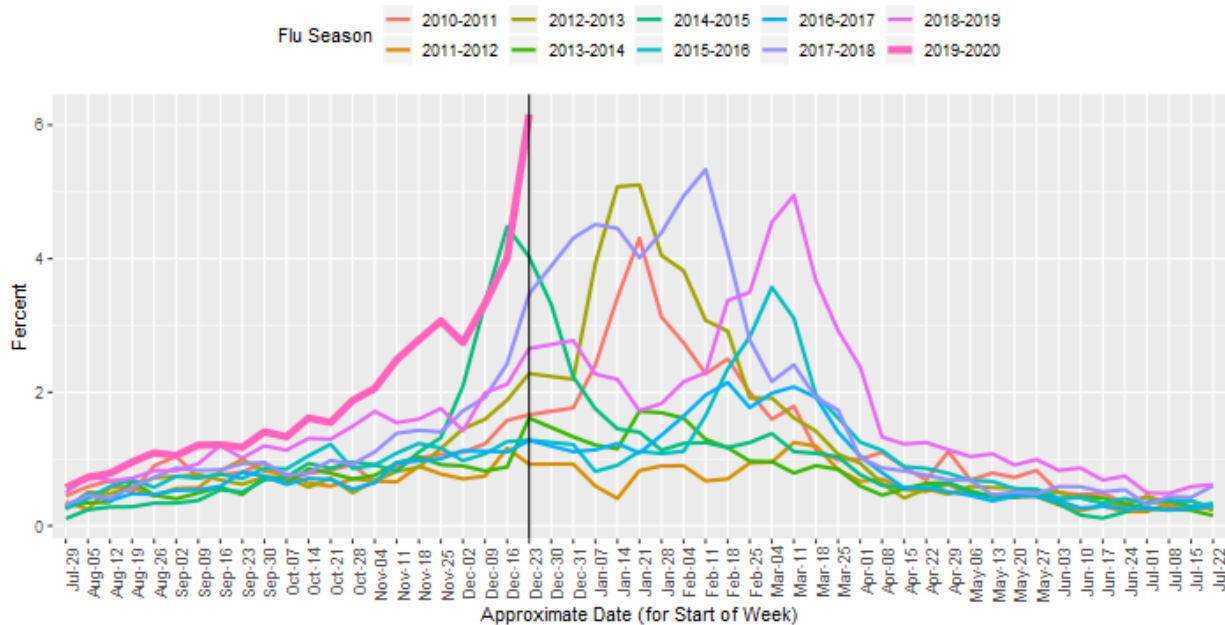

Updates on Most Recent Local Activity: Week 52 (December 22 – December 28)

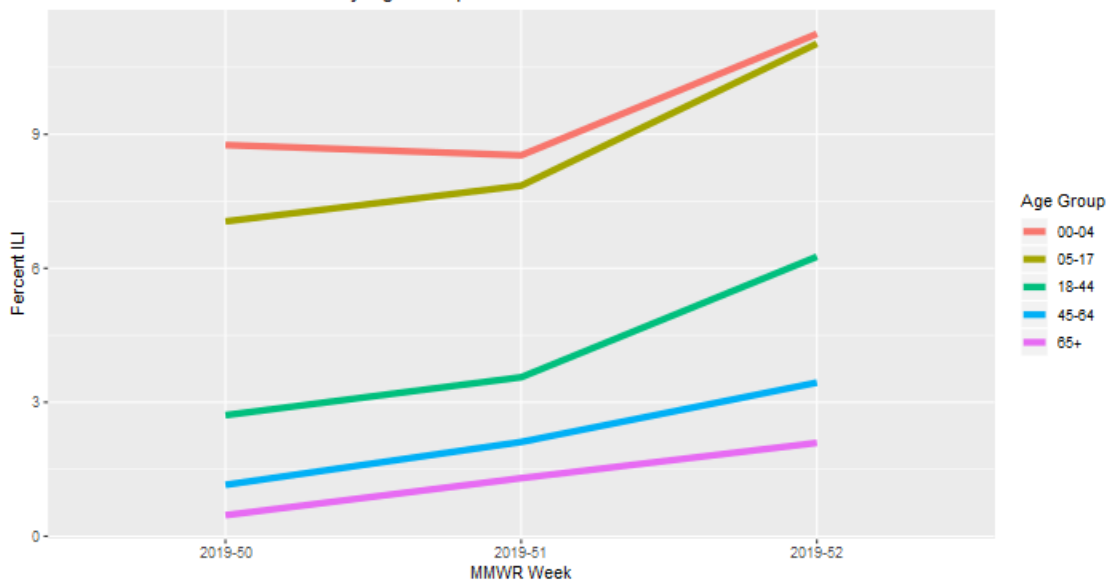
- During Week 52, **6.16% of Marion County ED visits had ILI symptoms.**
- There have been **less than five influenza-associated deaths** for Marion County residents this flu season.
- In Marion County hospitals' ED population, ILI was **most common in the 0-4 age group.** Among ED visits by 0-4 year olds, 11.25% was for ILI. ILI among ED visits by 5-17 year olds was next highest, at 11.03%.

Local (Week 51)

- The percentage of ILI related ED visits was 4.01%.
- Children age 0-4 had the highest age-specific percent ILI (8.53%).

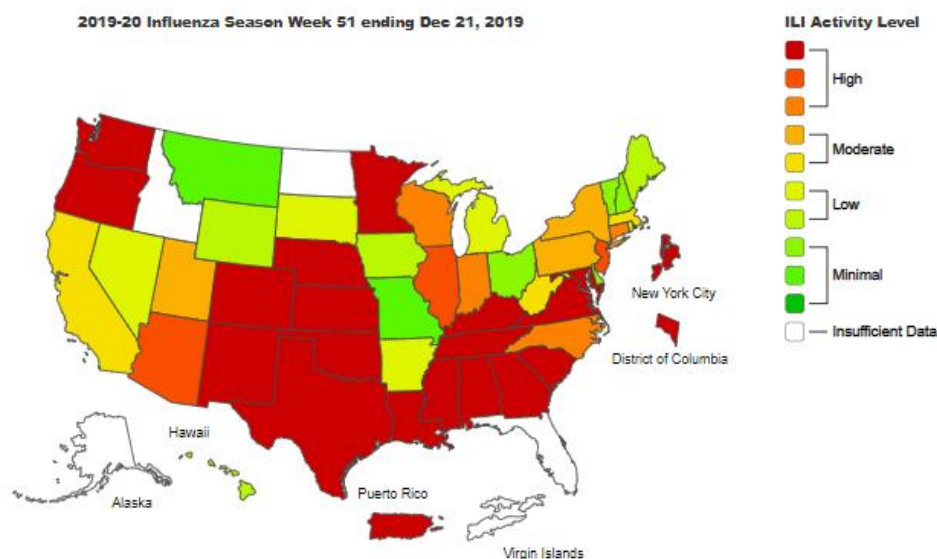

- Indiana is experiencing **widespread and high ILI activity**. For Week 51, ISDH reported 3.58% ILI at sentinel provider sites and 3.39% ILI ED and urgent care visits. This was **an increase for sentinel provider sites** (3.17% Week 50) and **ED and urgent care visits** (2.79% Week 50).
- There have been **seven influenza-associated deaths** this season
- **The percent positivity of influenza specimens tested in ISDH Laboratories increased** (Week 51: 89.5% vs Week 50: 60.7%). Of the 34 positive influenza specimens submitted: 22 were for influenza 2009 A/H1N1pdm virus, nine influenza B Victoria seasonal virus, two influenza A/H3 seasonal virus, and one influenza B Yamagata virus.

- **Influenza activity continued to increase in reporting jurisdictions.** The majority of jurisdictions had high and widespread influenza activity.
- **Outpatient visits due to ILI was at 5.1%**, as reported through the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet). This was lower **than Week 50 (3.9%)**.
- **Twenty-two influenza-associated pediatric deaths** have been reported to CDC this flu season.
- During Week 51, **positive influenza tests were higher in clinical laboratories** compared to Week 50 (22.1% vs 16.3% respectively). **Influenza A had less positive respiratory specimens than influenza B** (30.7% vs. 69.3% respectively).
- During Week 51, **58.1% of specimens were positive at public health laboratories**. Of those, the top three subtypes/lineages were: **influenza B – Victoria lineage (42.5%)**, **influenza A – (H1N1)pdm09 (35.9%)**, and **influenza B – lineage not performed (15.7%)**.
